## Aircraft and Waterborne Vessels Exclusion Amendment

It is hereby noted and agreed that General Exclusion Aircraft and Waterborne Vessels is deleted and replaced as follows:-

**We** will not indemnify **You** against **Your** legal liability arising out of the ownership, possession or use of any **Aircraft**, hovercraft, offshore installation or watercraft (other than hand-propelled or wind-powered watercraft whilst on inland waterways), except that this exclusion shall not apply to liability arising solely from parachute jumps undertaken by **You** or on **Your** behalf from any aircraft, provided that **You** have no ownership, operation, or control of the aircraft itself.
