DATA PROTECTION ACT 2018. We collect only necessary personal data to service your membership. As part of your membership, you will receive communications from British Skydiving by email. You can control your preferences at any time using the links provided in our emails.

PART 2 - ELIGIBILITY

1. To be eligible for Full Membership (Retired) the applicant must have been a Full British Skydiving member for a minimum of one year.
2. No longer jumping/rigging/packing or active participant /airside in the sport or any operational role.
3. AGREEMENT - You are required to sign the Agreement on the reverse of this application.
4. If at any time during the 12 months of 'Retired' membership, up to 31st March 2027, the 'Retired' member wishes to resume active skydiving or associated activities, that member must take out a Full membership. To do so the member must contact British Skydiving HQ. There will be an additional charge to take into account the addition of Third-Party Liability Insurance cover.

PART 3 - MEMBERSHIP AGREEMENT AND RISK ACKNOWLEDGEMENT

This agreement sets out the terms under which individuals participate in skydiving activities as members of **British Skydiving**, the trading name of the **British Parachute Association Ltd.**

Definition of "the Association"

In this agreement, references to British Skydiving or "the Association" shall include, where the context permits, British Skydiving, any affiliated Parachute Training Organisation (PTO), any instructor, rigger or packer (whether or not employed by a PTO), any other individual or corporate

member of British Skydiving, and any servant, agent or representative acting on behalf of British Skydiving or any affiliated Parachute Training Organisation.

This agreement applies to all categories of membership, including Full Members, Student Members, Tandem Student Members, Temporary Members and any other category of membership issued by British Skydiving.

This agreement does not restrict where a member may skydive but sets out the conditions under which a member participates in skydiving activities under British Skydiving governance, rules and insurance arrangements.

By applying for membership and participating in skydiving activities, you agree to the following.

1. Compliance with Rules and Policies

Members must comply with:

- the **Articles of Association**
- the **Operational Regulations and Safety requirements**
- the **British Skydiving Code of Conduct**
- all **Safeguarding policies and procedures**
- any lawful instructions given by instructors or authorised officials.

The current versions of these documents are available online.

2. Authority of British Skydiving

British Skydiving has the authority to investigate alleged breaches of its rules, regulations or policies.

Following investigation, British Skydiving may take disciplinary action including:

- suspension of membership
- restriction or removal of ratings or privileges
- revocation of membership.

British Skydiving shall not be liable for any financial loss, loss of earnings or consequential loss arising from such action.

3. Acknowledgement of Risk

Skydiving is an inherently dangerous activity.

Even when conducted with appropriate training, supervision and equipment, participation carries a **risk of serious injury or death**.

By participating in skydiving activities, members voluntarily accept these risks.

4. Medical Fitness

Members must ensure they are medically fit to participate in skydiving activities.

Members must complete any required **medical self-declaration or medical certification** required by British Skydiving.

If a member's health status changes in a way that may affect their ability to skydive safely, they must seek appropriate medical advice and inform the relevant instructor or Parachute Training Organisation before participating again.

5. Safety Responsibilities

Members must:

- follow all instructions given by instructors and authorised officials
- comply with all safety procedures and operational requirements
- act in a responsible manner that does not endanger themselves or others

6. Insurance

Retired Membership does not include participation in the **British Skydiving members' third-party liability insurance scheme**, no cover is provided for legal liability to third parties arising from skydiving activities undertaken as a member.

Instructor Insurance - Instructors who are members of British Skydiving cannot claim indemnity under the British Skydiving third-party liability insurance scheme if any Parachute Training Organisation for whom they are working at the relevant time is not a participating PTO which has made a contribution towards the insurance premiums payable by British Skydiving for such third-party liability insurance. Such instructors are therefore advised to arrange their own third-party liability insurance where appropriate.

7. Incident Reporting

Members must notify British Skydiving or the relevant Parachute Training Organisation **as soon as reasonably practicable** of any accident or incident involving injury to a third party or damage to property arising from a skydiving activity undertaken by them.

8. Data Protection

British Skydiving processes personal data in accordance with the **UK General Data Protection Regulation (UK GDPR)** and the **Data Protection Act 2018**.

Details of how personal data is used can be found in the Privacy Notice online.

9. Age Requirements

The minimum age for skydiving in the United Kingdom is **16 years**.

Applicants under the age of 18 must have consent from a **parent or legal guardian** before participating in skydiving activities.
